Opinion

Note No. 19 SIGNIFICANT ACCOUNTING POLICIES:

The significant accounting policies followed are stated below:

Although these estimates are based on management's best knowledge of current events and actions, uncertainity about the asumptions and estimates could result in the outcomes resulting a material adjustment to the carrying amount of assets and liabilities in future periods.

The Management believes that the estimates and assumptions used in the presentation of financial statements are prudent and reasonable. Actual result could differ from these estimates.





- Fixed Assets & Depreciation: Fixed assets are shown at their historical cost less depreciation and all direct cost attributable to fixed assets is also Capitalized and Depreciation is provided based on Written Down value method over the useful life of respective fixed assets in accordance with Schedule-II (Section 123) of Companies Act, 2013. The Residual value of all fixed assets has been prescribed at 5% of their original cost.
- Investments: The company has not invested in any securities (quoted or unquoted), immovable properties properties, or in partnership during the period under reporting and carrying value of investment reporting period is Rs. 72,509/-
- Valuation of Inventories: As there is no inventory as on the balance sheet date, question of valuation does not arise.
- Revenue Recognition: Revenue from rendering of services is recognized on performance of the service agreement, on the basis of completed service contract method and to the extent that it is probable that the economic benefits will flow to the company and the revenue can be reliably measured, and no significant uncertainty exists regarding the amount of consideration that will be derived. Revenue from interest are recognized on time proportion basis taking into account the amount outstanding and at the rate applicable.
- Employee Benefits: The Employee benefits payble only within 12 months of rendering the services are classified as short term employee benifits, such as salaries and allowances and the expected cost of bonus are recognized as an expense in the profit & loss statement for the period in which the employee renders the related servics. The company is not required to comply with provisions of Providend fund & ESI.
- h) Taxation: Provision is made for income tax and deferred tax liability as per the provision of AS-22.
